## TO KEEP YOU IN THE BIG PICTURE

A very special meeting: Special Meeting of the European Council (24-25 May). A special meeting of the EU leaders started on Monday when discussions were "hijacked" by the forced landing of a commercial flight by Belarus. As a result, the Monday "menu" saw a quick response to the Belarus act in addition to the planned discussions on Russia, relations with the UK, the Middle East and Mali. On the Tuesday "menu": Covid-19 and climate change. Here is the story, plus statement on Belarus.

Travel again: Parliament and Council reach provisional agreement on EU Digital COVID Certificate. The agreement has been reached just two months after the Commission's proposal. President von der Leyen said: "... At EU level, the system will be ready in the next few days. It is now crucial that all Member States press ahead with the roll-out of their national systems to ensure that the system can be up and running as soon as possible...".The certificate will cover Covid-19 vaccination, test or recovery and be available in a digital and paper-based format. It will be free of charge and Member States may use it for national purposes, if this is provided for in national law.

Firm commitment: Global Health Summit: EU launches initiatives to fight Covid-19 and avoid future pandemics: Leaders of the G20 committed on 21 May to a series of actions to accelerate the end of the Covid-19 crisis and better prepare for future pandemics. President von der Leyen also announced an initiative on manufacturing and access to vaccines, medicines and health technologies in Africa. The initiative is backed by €1 billion funding from the EU budget, European development finance institutions, such as the European Investment Bank (EIB). ## CALL FOR ACTION THIS WEEK ...

Share the conclusions from the Special Meeting of the European Council: Check out the latest state of play by following the <u>story</u> and share the results. On **climate change**: Remind your audience that the EU is the first major economy to commit to climate neutrality by 2050 and to an emissions reduction target of at least 55% by 2030. These goals are now enshrined into binding legislation, the European Climate Law. The EU leaders are expected to reaffirm the conclusions of 10-11/12/2020 and seek to provide additional guidance to the Commission.

You've seen the story on the EU Digital COVID Certificate. Now, tell the story! Join us in showing that the EU is firmly committed to restoring normal life. The Commission proposal is meant to give hope and reassurance to all European citizens.

**Talk about the Global Health Summit**: Consider this: The EU will come forward with a proposal in the WTO focusing on:

- clarifying and facilitating the use of compulsory licenses in crisis times like this pandemic (note a difference with the US-backed proposal to waive vaccine patents);
- · supporting the expansion of production;
- trade facilitation and limiting export restrictions.
